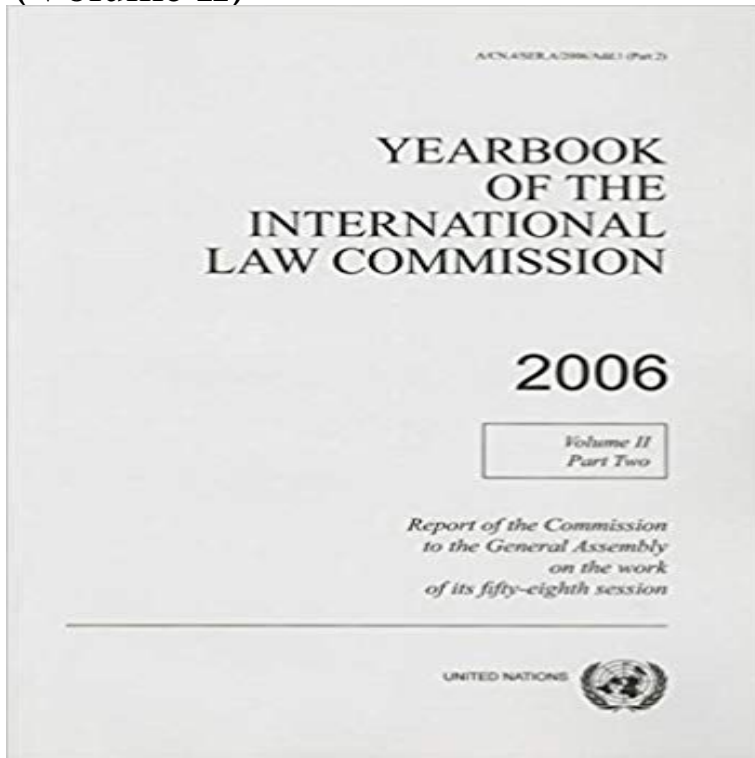


Yearbook of the International Law Commission 2006: Vol II Part 2 (Volume II)
